

PRIVACY

In accordance with Article 13 of Legal Decree No. 196 of 30 June 2003, we notify that Podere Rocche dei Manzoni s.a.s. di Migliorini Rodolfo & C., and that we guarantee within the framework of the legal guidelines that the processing of personal data occurs taking into account the basic rights and freedoms as well as the dignity of the person concerned (art 4, paragraph 1, letter i) of law) with particular reference to confidentiality, personal identity and the right to protection of personal data. PROCESSING OPERATIONS AND RELATED PURPOSES

All information you provide are the result of your choice: we do not have any illicit means of obtaining personal information without your consent. The information that you provide us by sending an e-mail and / or by completing the registration form is used only to respond to your questions or fulfil your requests, only with express statement of consent by you, the Our organization may use your personal data for purposes such as sending promotional and commercial information or new offers of related products or services, and finally, only after a further expression of their specific consent, your personal data may be made available of our trading partners are able to transmit information or to send promotional material of your interest.

MODALITIES OF DATA PROCESSING

The data processing can take place with or without the help of electronic or automatic means and encompasses everything provided for in Art. 4, Paragraph 1a of Legal Decree No. 196 of 30 June 2003 and for the relevant procedures necessary for data processing (processing means any operation or series of operations, even performed without the aid of electronic means, concerning the collection, recording, organisation, conservation, consultation, elaboration, modification, selection, extraction, comparison, use, interconnection, freezing, communication, disclosure, deletion and destruction of data, even if not recorded in a database); in any event, the data processing is carried out under the observance of all safety measures which guarantee security and confidentiality. Personal Data will be processed only by persons appointed directly by Data Controller, Podere Rocche dei Manzoni s.a.s. di Migliorini Rodolfo & C. who has prepared all necessary security measures to minimize the risk of breach of privacy by third parties, constantly updated and whenever it proves indispensable.

ONLINE BROWSING DATA

The computer systems and software used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the communication protocols of the Internet. It concerns information that is not collected to be associated with specific individuals but, for their own nature, through elaborations and associations with data owner by third parties, they could allow the identification of the visitor users. This category of data includes IP addresses, names in control of computers used by users who connect to the web site, addresses URI (Uniform Resource Identifier) of the requested resources, timetable of the request, method used to subject the request to the server, dimension of the file obtained in reply, number code indicating the condition of the reply given by the server (successful, error,..) , other

parameters referring to the operating system and computer environment of the user). These data are only used to extract anonymous statistical information on website use as well as to check its functioning; they are erased immediately after being processed. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the Site.

FACULTY TO PROVIDE YOUR DATA

The optional, explicit and voluntary sending of e-mail messages, to the addresses posted on the Web Site entails the subsequent acquisition of the sender address, which is necessary to answer any queries, as well as of any other personal information included in the message.

COOKIE

Cookie are small text files that are sent by the sites visited by users and are registered on their computer or mobile device to then be re-transmitted to the same sites on the next visit. There are two main categories: "technical" cookie and "profiling" cookie. This site contains the so-called "technical" cookie and they are used solely for the purpose of "making the transmission of a communication over an electronic communications network, or as strictly necessary for the provider of an information society service explicitly requested by the Subscriber or user to provide such service" (see article 122, paragraph 1, of the code): can be divided into navigation or session cookie that guarantee normal browsing and using the website; cookie analytics, treated as technical cookie where used directly from the site operator to collect information, in the aggregate, the number of users and how they visit the same site; functionality cookie, which allow the user browsing according to selected criteria (for example language, selected products for purchase) in order to improve the service to the same.

The use of "technical" cookie (session variables whose values are stored on the hard disk of the device and that can

still be deleted: you can also disable cookie by following directions provided by the major browser, see below) is strictly limited to transmitting session identifiers (consisting of random numbers generated by the server) and data of use of the software needed to enable a safe and efficient site navigation: these session variables (cookie) can avoid the use of technologies that could compromise the privacy of the users and not allow the acquisition of personal identification data. This site does not use "profiling" cookie (aimed at creating users profiles and used in order to send advertising messages in line with their preferences). This site uses "third-party" cookie designed to receive on your device, while browsing a site, cookie set by different websites and servers (storing information occurs at third parties): an example is the presence of "social plugin" for Facebook, Twitter, Google+ and LinkedIn (these are parts of the page visited and directly generated by these sites, integrated into the host page of the site) the use of which is aimed at sharing content on social networks (the presence of these "plugs" involves the transmission of cookie to and from all sites operated by third parties: the management of the information collected by "third parties" shall be governed by their own policies, so please read further).

RIGHTS OF THE PERSON CONCERNED
